In case of Unitholders who have registered for any of the systematic transaction facility viz., Systematic Investment Plan (SIP), Systematic Transfer Plan (STP) or Dividend Transfer Plan (DTP) in any of the Existing plan(s)/option(s), the said registration for SIP, STP(in), or DTP(in) will continue for its balance tenure under the respective Reclassified plan(s)/option(s) as stated above.

All the other terms and conditions of the Scheme Information Document of the Schemes, read with the addenda issued from time to time, will remain unchanged.
