#### **Acceptance of Systematic transactions**

Further to our addendum dated April 30, 2022 and June 21, 2022, investors are hereby informed that fresh registration under Systematic Investment Plans (SIP)/ Systematic Transfer Plans (STP) in following schemes (Designated Schemes) is being reactivated, subject to compliance with conditions provided in table below with effect from November 7, 2022:

1. Franklin Asian Equity Fund;
2. Franklin India Feeder - Franklin U.S. Opportunities Fund
3. Franklin India Feeder - Templeton European Opportunities Fund

It is clarified that Lumpsum subscription/ Switch- in still remain suspended. Manner of suspension is clarified below:

1.	Lumpsum subscription/ Switch- in	Shall not be accepted
2.	Fresh registration under Transfer of Income Distribution Cum Capital Withdrawal Plan (TIDCW)/ Daily and Weekly frequency under Systematic Transfer Plans (STP) for investing into any of the Designated Schemes	Shall not be accepted
3.	Fresh registration under Systematic Investment Plans (SIP)/ Systematic Transfer Plans (STP) for investing into any of the Designated Schemes	Registration of Monthly and Quarterly frequency SIP / STP shall be accepted with effect from November 7, 2022 and installments shall be processed subject to compliance with Scheme Information Document(s) and other Regulatory limits.
4.	Installments of SIP / STP/ TIDCW existing as on February 1, 2022	Existing SIP / STP/ TIDCW instalments will be processed subject to compliance with Scheme Information Document(s) and other Regulatory limits.
5.	Switch-out, redemptions, registration of fresh systematic withdrawal	All these transactions will continue to be processed.

	plan, and instalments of existing systematic withdrawal plan (where one of the Designated Schemes is the source scheme)	
6.	Intra scheme switches between Plan(s) and Option(s) in the same scheme	All these transactions will continue to be processed

Investors may note that the total investment in overseas funds or securities across all schemes of FTMF shall be capped at the existing level as of February 1, 2022.

The aforesaid suspension is temporary in nature and will continue only till further enhancement of limit by Regulators in this regard.

This addendum forms an integral part of the Scheme Information Document and Key Information Memorandum issued for respective schemes, read with the addenda issued from time to time.
